GENERAL REGULATIONS

COVID Protocols:

At this time it is the intention of the conference organizing committee is to hold this conference in a hybrid format, both in person and virtually. We will continue to monitor local and PNNL COVID guidelines for meeting in person and make a final decision for the conference format by February 1, 2022. Prior to sponsor payments being collected.

Exhibition Guidelines
